



Local Financial Advisor Named President of MDRT Foundation

BRISTOL, England – (September 6, 2022) – Bristol-based financial advisor Adrian P. Baker, DipPFS, will succeed John F. Nichols, MSM, CLU, as the 57th President of the MDRT Foundation, the charitable arm of Million Dollar Round Table (MDRT), the Premier Association of Financial Professionals®.

Baker will tap into his past professional and charitable experiences in his new role to elevate the global impact of the MDRT Foundation. He hopes to leverage technology to facilitate the Foundation's goal of awarding 1.8 million USD in grants to non-profits around the globe in 2023.

A well-established philanthropist, Baker has found charitable work to be second nature. Baker founded the charity Baby Check Bath which provides infants with free cranial osteopathy, a non-invasive treatment that helps newborns with feeding difficulties. Baker himself received this treatment to alleviate back pain from his 48 years as a martial arts instructor. He also supports organizations aiding abandoned animals in need, as well as supporting a local children's hospice, and maintaining a charity through his own practice.

Baker has served in numerous capacities within MDRT and the MDRT Foundation, including MDRT membership committee chair in 2015 and serving on the MDRT Foundation Board of Trustees for two years. A Royal Order Excalibur Knight, Baker has been giving to the MDRT Foundation since 1986. As a 40-year MDRT member with 12 Court of the Table honors and one Top of the Table honor, Baker will also draw on his work-hard attitude from his successful career in financial services to aid the Foundation in supporting non-profit organizations around the world.
